

Count 1

George Walker BUSH, a citizen and former President of the United States of America and former Commander in Chief of the U.S. Armed Forces, between approximately September 2001 and at least June 2008, in the District of Columbia and other locations in the United States, and *inter alia* in the U.S detention facility in Bagram in the country of Afghanistan, and in the U.S detention facility in Kandahar in the country of Afghanistan, and in the country of Pakistan, and in the U.S detention facility in Guantánamo Bay in the country of Cuba, did order, authorize, aid, abet, counsel, condone or exercise command responsibility over acts of torture committed by officials of the U.S. government against a person in U.S. custody, to wit: Sami EL-HAJJ, a national of Sudan, thereby committing an offence contrary to section 269.1 of the Criminal Code of Canada.

Count 2

George Walker BUSH, a citizen and former President of the United States of America and former Commander in Chief of the U.S. Armed Forces, between approximately September 2001 and at least January 20, 2009, in the District of Columbia and other locations in the United States, and *inter alia* in the U.S detention facility in Kandahar in the country of Afghanistan, and in the country of Pakistan, and in the U.S detention facility in Guantánamo Bay in the country of Cuba, did order, authorize, aid, abet, counsel, condone or exercise command responsibility over acts of torture committed by officials of the U.S. government against a person in U.S. custody, to wit: Muhammed KHAN TUMANI, a national of Syria, thereby committing an offence contrary to section 269.1 of the Criminal Code of Canada.

Count 3

George Walker BUSH, a citizen and former President of the United States of America and former Commander in Chief of the U.S. Armed Forces, between approximately September 2001 and at least January 20, 2009, in the District of Columbia and other locations in the United States. and *inter alia* in the U.S detention facility in Bagram in the country of Afghanistan, and in the "Dark Prison" in the country of Afghanistan, and in the country of Pakistan, and in the U.S detention facility in Guantánamo Bay in the country of Cuba, and in the country of Jordan, did order, authorize, aid. abet. counsel, condone or exercise command responsibility over acts of torture committed by officials of the U.S. government and the government of Jordan against a person in U.S. custody, to wit: Hassan BlN ATTASH, a national of Yemen, thereby committing an offence contrary to section 269.1 of the Criminal Code of Canada.
